## Coronavirus worker support payment

The Victorian government is providing one off payment to support Victorian workers who are required to self isolate due to Coronavirus.

### The following payments are available:

1. A one off \$300 payment whilst waiting for Coronavirus test results. This payment is available for Victorian workers including working parents who are required to self-isolate while waiting for the results of their Coronavirus test or their children's test.
2. A one off \$1500 payment for Victorian workers with a positive Coronavirus test or close contact of someone with Coronavirus.

If you or your child under 16 years have been instructed to the Department of Health and Human Services to self isolate at home because you have been diagnosed with Coronavirus, or are in close contact of someone with coronavirus, you may be eligible for this payment.

### To receive these payments the worker must be:

- Aged 17 years and over
- Currently living in Victoria (including people on temporary protection visas and temporary working visas 457 and 482)
- In employment and likely to have worked during the period of self-isolation and are unable to work because of the requirement to stay at home.

### You cannot receive the payment if you:

- Are receiving any payment from work.
- Have any sick leave or pandemic leave payments owing to you.
- Are receiving any Government income for example job keeper.

You do not need to be an Australian citizen or permanent resident to receive these payments.

You can be employed as permanent, casual, part-time, fixed term, or self employed to receive these payments.
