The Program

The Care Hub is a new initiative that brings together a number of organisations to form an integrated team of professionals to support Children and Young People in the areas of Mental Health, AOD, Cultural Connection, Family Work, Community Engagement and Therapeutic Support.

The team will be based from a single location in Bendigo, forming a collaborative, integrated team of staff helping support those entering care for the first time. The aim of the Care Hub is to provide a wraparound service and team of staff to support effective assessment, planning and intervention to help support the Children, Young People and Families through the process and ensure all needs are met.

The integrated team will include professionals from Anglicare Victoria (as the Lead Organisation) and a host of other partner organisations, all working together to do better. The Care Hub will provide early assessment, planning and wrap around supports by a single integrated team (formed from a consortium of organisations) for children and young people who are first time entrants into care.

The services and support are delivered in a child-centered, family focused way and works alongside families to address the changes that may need to occur for their child/ren or young person to be safe at home.

Position Role

The aim of the Family Services Practitioner role within the Care Hub is to provide quality in-home and community interventions, with high intensity and flexible service delivery hours.

This position sits within the Family Services Team at BCHS but will work as an integrated member of the Care Hub team with partner agencies. The Family Services team at BCHS provides individual support and case coordination to children, young people and families to make sustainable changes in the best interests of children and young people. Family Services works as part of the broader family services system, and the work is underpinned by legislative frameworks.

- The Children, Youth and Family (CYFA) Act 2005 requires that family services works in ways that reflect the Best Interest Principles and the associated provisions of the CYFA, to work as part of an integrated family service system to support children, youth and families with a focus on early intervention and prevention.
- The Best Interest Framework provides a common basis for professionals to work together with local communities and other services to meet the needs of vulnerable children and their families.
- Family Services provides a proactive outreach service that supports families to develop strategies and create changes to ensure the best interests of children and young people are central.
- Family Services works with local communities and other services to meet the needs of vulnerable children and their families. This includes encouraging a consistent focus on safety, stability and the development of positive outcomes, whilst viewing the child's experience through the lens of the age and stage of the child, their culture and gender.
- Family Services utilises best practice principles to ensure that families are supported to be kept out of the child protection system, where possible.

Position Responsibilities

The responsibilities of the Care Hub position within the Family Services team are:

- Utilise an assertive outreach process through a variety of platforms to engage with children, young people and families who have complex needs, with a focus on reunification and the safety and wellbeing of children and young people within the family home.
- Actively support families to develop clear goals and achieve outcomes in the best interests of children and young people, and work with the family to support reunification or meaningful contact with the child or young person (dependent on the case plan).

- Undertaking regular risk and needs assessments and case work, utilising the Best Interest Framework, strengths-based practice and other evidence-based approaches to support the safety and wellbeing of children and young people.
- Provide advocacy, information and resources to support family change
- Develop, participate, and facilitate group sessions with children, young people and families.
- Support families to connect with formal and informal networks that will support them to sustain change in the best interests of the children.
- Make an active commitment to the development and maintenance of a learning environment and cohesive multi-disciplinary team across the consortium; through staff meetings, team meetings, staff development, supervision and reflective practice.
- Develop good working relationships with consortium partners including Aboriginal services to ensure cultural safety in our practice; to promote best outcomes for children, young people and their families.
- Work within a collaborative care team approach with consortium members and relevant stakeholders, including Child Protection, to promote best outcomes for client.
- Meet the requirements of the program in terms of targets, data collection and reporting
- Other duties as directed.

Key Selection Criteria

Essential

1. A qualification in Social Work, Community Services, Community Welfare or Community Development related discipline.
2. Demonstrated experience in providing assertive outreach and case management and support to children, youth and families within an empowerment framework, with a comprehensive understanding of best practice principles, consent, advocacy and confidentiality.
3. Demonstrated experience and skills in assessment and identifying risk in families.
4. Demonstrated understanding of attachment and trauma - and how this may impact on children, young people and their families.
5. Demonstrated experience in building rapport and professional relationships with consumers from diverse backgrounds as well as excellent interpersonal and communication skills with children, youth, families and professionals.
6. Demonstrated ability to work independently as well as a member of a multidisciplinary team.
7. Demonstrated understanding of the impact and gendered nature of family violence.
8. A sound knowledge of the Victorian Children, Youth and Families Act 2005.
9. Ability to maintain a positive attitude to the program and service.
10. Ability to provide vaccination status information that meets the requirements for healthcare workers.
11. Current Driver's License.
12. Current Working with Children Check.

Desirable

1. Excellent organisational and time management skills.
2. Comprehensive knowledge of the local service system.
3. Intermediate to high level computer skills such as use of Microsoft Office programs including Microsoft Teams and electronic client management systems.
4. The ability to confidentially maintain accurate records in accordance with BCHS procedures.

Probationary Period

Employment with BCHS is conditional on satisfactorily completing a probationary period of six (6) months from date of commencement.
