The Role of the Team

Head to Health is a unique service, and the first state-wide step towards integrating the mental health system and coordinating care for people, when and where they need it most.

The Head to Health program works closely with the Mental Health services team who provide a range of services including Generalist Counselling, Culturally Sensitive Counselling, Primary Mental Health Clinical Care Coordination (PHMCC) Psychological Treatment Services (PTS), Child Mental Health, Suicide Prevention and Employee Assistance Programs (EAP).

Position Role

This position sits with the Head to Health mental health hub and works within a multidisciplinary team and alongside existing services. As one of the first contact points for consumers, the Intake Clinician will need to build a positive rapport with a wide range of consumers, the team and existing services.

The focus of this role will include the provision of intake utilising the IAR tool, assessment, clinical case reviews, consumer referral, educational; programs, service liaison, consumer advocacy and other tasks as identified to address consumer needs. You may also hold a small caseload. A commitment to professional development and attendance to all provided supervision is required.

The successful applicant will be required to:

1. To provide intake, screening and bio psychosocial assessments with consumers seeking services through the HeadtoHealth Hub addressing and identifying needs and risks. You will support vulnerable people, including frontline health workers, older Australians, Aboriginal and Torres Strait islander People and those who are socially isolated or financially impacted by the COVID-19 pandemic to access mental health services and supports.
2. Conduct risk assessments including assessment of suicide risk and violence risk, developing action plans to mitigate risk, and providing follow up and support and referral for treatment. High risk clients must be promptly reported to the Senior Leader for appropriate action.
3. Be part of a team to provide on-site mental health support, including referrals to more intensive mental health care or social supports as needed.
4. Support General Practitioners and other primary health care providers by assisting in the referral, intake and assessment of consumers into the mental health hub or other services as required.
5. You will deliver evidence-based clinical primary mental health care services and care coordination in line with a best practice stepped care approach.
6. Provide high quality, evidence-based treatment, information and support to people who may be experiencing psychological distress or mental ill-health.
7. Boost the capacity of existing primary mental health services commissioned by Murray PHN with referral options across private, non-government and hospital-based services to best meet the needs of clients.
8. Support GPs, public and private hospitals and emergency departments by providing accessible mental health care.

Position Responsibilities

The responsibilities of the position are:

1. Provide intake, assessment and triage of people experiencing moderate mental health concerns and develop Individual Treatment Plans with clients as required. This includes identifying client needs across a range of domains and initiating and following up referrals to other service providers as needed.
2. Provision of Initial Assessment and Referral IAR (if not already undertaken) for walk in clients or direct referrals into the service.

3. Provide intervention/s for consumers with moderate health concerns, including the provision of a range of evidence-based approaches such as : brief interventions; single session therapy; and other strategies suitable for use with individuals experiencing psychological distress.
4. Undertake care co-ordination and collaborative care planning.
5. Undertake facilitated referrals, warm referrals or linkages to step up or down support. e.g. Acute-specialist service or self-help services
6. Conduct regular 3-month service review of clients or more frequently as clinically indicated.
7. In conjunction with the Senior Leader and other colleagues; work effectively with a range of other health and welfare services to develop or strengthen referral pathways into the mental health services and improve care planning systems to support better outcomes for clients.
8. Participate in group and/or individual clinical supervision and commit to critical reflection and discussion of values and ethical conduct.
9. Participate in line management supervision and discussion of all clients including those that present a risk to self, counsellors and or organisation.
10. Accurately record and document client and administrative information and collect and collate data within given timeframes.
11. Contribute to service integration, team development and BCHS strategic directions.
12. Undertake responsibilities of the position adhering to:
 - a. professional standards, relevant legislation and Occupational Health and Safety Legislation and requirements.
 - b. Working within current equity and access legislation/standards inclusive of all abilities, cultures, genders, sexuality, age and faith.
13. Perform other duties as directed that are within the limits of the staff member's skill, competence and training and the scope of the staff member's award/agreement classification.

Key Selection Criteria

Essential

1. Tertiary qualification with current registration with the Australian Health Practitioner Regulation Agency (AHPRA) with Mental Health credentialing, or Australian Association of Social Workers (AASW) with Mental Health accreditation or willingness to work towards credentialing / accreditation.
2. Minimum two (2) years' experience working in the Mental health sector, with people experiencing psychological distress, or with people with complex needs including mental health issues.
3. Demonstrated skills and experience in conducting assessments with people experiencing psychological distress, and in the development of Treatment/Care Plans in collaboration with clients and families.
4. Demonstrated ability to engage and form therapeutic relationships with people from diverse ages and backgrounds in a variety of settings.
5. Ability to manage a complex case load and provide demand management function (with support) as required.
6. Personal commitment to promoting equality, diversity and human rights in all aspects of service delivery.
7. Demonstrated understanding of, and ability to maintain accurate and confidential records utilising electronic Client Management Systems as well as accurately recording targets and associated compliance documentation.
8. Excellent interpersonal skills and communication (verbal and written) skills.
9. Demonstrated ability to work as a member of a multidisciplinary team.
10. A valid Working with Children Check.

11. Ability to provide vaccination status information that meets the requirements for healthcare workers.
12. Current Driver's Licence.

Desirable

1. Demonstrated experience building relationships and partnerships with other services and programs to optimise client outcomes.
2. Intermediate to high level skills in Microsoft Office programs.

Probationary Period

Employment with BCHS is conditional on satisfactorily completing a probationary period of six (6) months from date of commencement. During this period your performance will be reviewed with your Senior Leader and, assuming this is mutually satisfactory, your employment will be confirmed at the end of this period.

Staff Review & Development (SRD)

Each BCHS staff member is required to participate in the annual SRD process. The SRD will be based on the Position Role and Responsibilities and Key Selection Criteria in addition to the relevant Branch and Team Plans and the following Performance Indicators.

Position Performance:

- Provide counselling and group work with demonstrated positive outcomes for clients through comprehensive assessments, case planning and clinical reviews.
- Show evidence of an integrated service delivery approach for clients.
- Knowledge and compliance with BCHS privacy and confidentiality procedures.

Communication and Team Work:

High level communication and interpersonal engagement that contributes to productive and collegial relationships between staff and with consumers

- Display your capacity for self-awareness through reflection, planning and communication.
- Show evidence of your ability to work co-operatively within a team to achieve team goals.
- Establish and develop as key functions of relationship management, regular and professional communication with all your relevant colleagues.
- Demonstrate alignment and integration of practice according to BCHS' Vision, Values, and Strategic Directions.

Self-Management:

Demonstrated experience and understanding of the need for ongoing personal and professional development that contribute to self-satisfaction and professional growth.
