#### **TEAM ROLE**

The Loddon Children's Health and Wellbeing Local (LCHWL) provides a range of health and wellbeing services to children up to 11 years of age who may be experiencing some challenges such as developmental, emotional, relational or behavioural concerns. Services are available to families across the Shires of Campaspe, Central Goldfields, Loddon, Macedon Ranges and Mt Alexander, and the City of Greater Bendigo. The LCHWL is an innovative model co-designed with partners – paediatric service providers, and people with lived experience – to provide a regionally based system response that improves access across prevention, primary and tertiary care in the Loddon region. The service is particularly targeting those children who are not accessing support under other mechanisms such as NDIS.

Services provided through the LCHWL include paediatric health, mental health support, parenting support, specialist assessments, allied health, family services, care coordination and access to peer support from team members with a lived or living experience of caring for a child with developmental, emotional, relational or behavioural concerns.

The LCHWL has recently been established in response to the Royal Commission into Victoria's Mental Health System and led by Bendigo Community Health Services (BCHS) in partnership with Bendigo Health and regional partners Bendigo and District Aboriginal Cooperative, Njernda Aboriginal Corporation, Echuca Regional Health, Dhelkaya Health, Sunbury & Cobaw Community Health, North Central LLEN and Maryborough District Health.

## **POSITION ROLE**

This position provides an opportunity for a passionate and suitably qualified and experienced Allied Health Clinician to be a part of a multidisciplinary team providing an effective and collaborative service to children and their families, assisting to ensure they reach their full potential.

The Allied Health clinician will work in collaboration with a multi-disciplinary team including Paediatricians, GP's, Nurses, other Allied Health clinicians, a Psychiatrist, Family Services and Mental Health clinicians to provide a holistic assessment. This ensures early intervention for children and their families by delivering holistic family centred care that responds to the changing needs of children and their families.

## **POSITION RESPONSIBILITIES**

## The responsibilities of the position are:

- Work independently and collaboratively, providing assessment and interventions for children experiencing developmental, emotional, relational, and behavioural challenges.
- Completing relevant formal and informal Allied Health assessments and contributing to formulation of diagnosis.
- Contributing to the development and delivery of education sessions and group programs.
- Travel within the Loddon Campaspe regions to deliver outreach services where required.
- Gather information and develop care plans to minimise families having to repeatedly tell their story.
- Support tailored and coordinated care with therapeutic coherence.
- Advocate for service based on identified needs.
- Provide intervention/s for patients, including the provision of a range of evidence-based approaches such as brief interventions, single session therapy, and other strategies suitable for use with individuals experiencing mental health and wellbeing concerns.

- Undertake facilitated referrals, warm referrals or linkages to other services.
- Participate in internal case coordination and conferencing as a member of a multidisciplinary team.
- Accurately record and document client and administrative information and collect and collate data within given timeframes.
- Participate in continuous quality improvement activities.
- Participate in the development of policies, procedures and processes that impact on the service and on the achievement of relevant accreditation standards.
- Maintain and develop professional skills, in addition to monitoring new developments through continuing professional development.
- Participate in the monitoring and review of the demand for Local services to ensure services remain accessible and equitable.
- Other duties as directed as relevant to improvement of the role.

## **KEY SELECTION CRITERIA**

- 1. Tertiary qualifications with current relevant registration.
- 2. Experience in or a desire to develop skills in the Paediatric field.
- 3. Demonstrated skills and experience in conducting assessments and developing care plans for children and families.
- 4. Demonstrated understanding of the issues which impact vulnerable families in the catchment, including an understanding around trauma, child development and attachment.
- 5. Demonstrated skills and experience in assisting families where children are at risk, including a sound understanding of the service system and referral pathways for families.
- 6. Proven ability to manage a complex case load and provide demand management function (with support) as required.
- Excellent interpersonal and communication skills and a high level of emotional intelligence.
- 8. Ability to work collaboratively within a multidisciplinary team to facilitate a holistic approach to care.
- 9. Knowledge of family centred practice and family led planning.
- 10. Sound knowledge of the protective factors and contributors in relation to health inequality and vulnerability.
- 11. Demonstrated understanding of diversity and inclusiveness.
- 12. Understanding of broad service health and wellbeing system for children and families.
- 13. A passion for working with children and families to increase health literacy and enhance health and wellbeing.
- 14. Current Working with Children's Check.
- 15. Current driver's licence.
- 16. The successful applicant will also be required to undertake and complete a Satisfactory National Police Check.
